I. Contest purpose:

- ✓ Setting and popularizing choreographic works, searching for new vibrant choreographic pieces, and identifying young talented performers;
- ✓ Searching in Ukraine and abroad for talented and gifted choreographers who have significant achievements in creating choreographic pieces, dance performances, and performances;
- ✓ Establishing a creative atmosphere and exchanging experiences among the participants of the contest.

II. Contest organizing committee:

IV. Terms and Venue of the contest:

The contest for young choreographers "DANCE GENERATION" will take place on April 27, 2024, in Kyiv, at the concert hall of Borys Grinchenko Kyiv Metropolitan University, located at 13-B Levka Lukyanenko Street, Kyiv, Ukraine (near the Minska metro station).

V. Nominations:

- ✓ Modern dance:
- ✓ Classical dance;
- ✓ Folk stage dance;
- ✓ Ballroom dance.

VI. Categories:

- ✓ Category A (students of colleges of culture and arts);
- ✓ Category B (higher education institutions students majoring in «Choreography»);
- ✓ **Category C** (young choreographers up to 35, performers professional dancers or experienced dancers);

- ✓ Category C1 (young choreographers up to 35, performers students of children's dance groups);
- ✓ **Category Professional** (choreographers from 35 to 45, performers students of children's dance groups);
- ✓ Category Professional 1 (choreographers from 35 to 45 років, performers professional dancers or experienced dancers);
- ✓ **Category V** dance video project (exclusively foreign groups).

VII. Program requirements of the contest:

- ✓ The contest is open to choreographers up to 45 years old and students of choreographic groups, art school pupils, lyceum students of art schools, and students of higher educational institutions.
- ✓ The contest is held both "live" (performance on the university stage) and "online" (exclusively for foreign groups) (uploading video recordings of dance contest numbers to Google Drive).
- ✓ Each choreographer may present no more than two choreographic works in one category. The total duration of the performance should not exceed 4 minutes. The organizing committee reserves the right to reject applications in case of a large number of participants.
- ✓ **Applications** for participation in the contest are accepted **until March 30**, **2024.** The application form for participation in the competition of young choreographers.
- ✓ Payment for participation is made after confirmation of your application by the organizers via email or the phone number provided in the application.

- ✓ **Final confirmation of participation in the contest** is made after the confirmation by the coordinating committee of your application by the phone number specified in the application after sending a copy of the receipt for the payment of the charitable contribution to the email address dancegeneration 24@gmail.com.
- ✓ **Phonograms** should be sent to the organizers' email address dancegeneration24@gmail.com in MP3 format along with the application, indicating the name of the composition and the group according to the submitted application. Phonogram verification takes place with the sound engineer during the stage rehearsal from **8:00 to 10:00**. It is mandatory to have a spare phonogram on a separate flash drive! There should be no files on the flash drive except for the contest tracks.

✓ Stage rehearsal will be held from 8:00 to 10:00 on the day of the contest according to the approved stage plan following the order of the submitted applications.

VIII. Evaluation Criteria:

- ✓ general artistic level of staging considering the age of performers;
- ✓ the relevance of the chosen theme and the individual choreographer's vision;
- ✓ independence of the choreographic decision of the choreographer's composition;
- ✓ originality of the embodiment of the plan of the performance, the spectrum of used composite solutions and techniques;
- ✓ conformity of choreographic decision to used musical material, artistic design (props, costume, etc.);
- ✓ the level of performers' skill;
- ✓ the quality of the used musical material;
- ✓ highly artistic approach to creating a video of choreographic work (video project).

Evaluation of choreographic works will be carried out by a highly professional jury, composed of experts from various fields of choreographic art: leading figures in culture and the arts, honored artists, active choreographers, and directors.

Based on the jury's voting results, laureates of the 1st, 2nd, and 3rd degrees (which are not duplicated), contest diploma recipients, and winners of special prizes are determined in each category.

The right to award the highest prize of the competition, the Grand Prix cup, remains with the judging panel. The contest results are not subject to discussion.

The festival organizing committee is solely responsible for organizational matters and does not influence the jury's decisions regarding the participants' assessments.

IX. Financial terms:

Participants are required to pay a charitable contribution, the amount of which is: Solo - 700 UAH.

Duet – 600 UAH per participant.

Trio, quartet – 600 UAH per participant.

Dance project (exclusively for foreign groups) – 300 UAH per participant.

Choreographic composition from 5 persons – 400 UAH per participant.

Choreographic composition from 15 persons – 350 UAH per participant.

Payment for participation is made after confirmation by the coordinating committee of your application by e-mail or by phone number specified in the application form.

Expenses for travel (transportation, accommodation, participation) are covered by the traveling organizations.

The contest organizing committee does not provide accommodation or meals for the participants

X. Application Forms:

- The participant application form and phonograms are filled out in Google Forms: The application form for participation in the contest of young choreographers.
- The presence of phonograms during the performance is mandatory!
- The deadline for submitting application forms is 5:00 PM on March 30, 2024.
- The program indicated in the application form cannot be changed later than 10 days before the start of the contest.

XI. Conditions of the contest:

The contest will take place on April 27, 2024, at the Borys Grinchenko Kyiv Metropolitan University.

The organizing committee reserves the right to record the competition and broadcast the performances.

During air raid alerts according to Order No. 336 dated June 30, 2022, all attendees must adhere to safet "Follow the news on the official competition page:"y regulations and take shelter at the following address: 13-B Levka Lukyanenko Street.

The award ceremony for participants will take place on April 27 after the completion of the contest program.

The contest organizing committee reserves the right to make changes to the regulations and the contest schedule.
